**SPEECH OF MRS. EUGENIA MORALES
SUB-DIRECTOR OF CFIA**

Mr. Prof. Stig Enemark, President of the International Federation of Geometricians, Mr. President .I General Board of Director of the Federated School of Engineers and architects, engineer Juan Manuel Castro Alfaro, especial guests, and all the participants

Good afternoon. I go to you, in the first place, to give a kind greeting from the Administration of the Federated Asociation of Engineers and Architects of Costa Rica (CFIA), by the success achieved within the framework of the Sixth Regional Conference of the FIG.

The subjects developed in this forum have a transcendental importance within the administration of the coastal zones. It is also important to focus our interest in the management of territorial plans and they allow to established strategies that facilitate the classification and representation of the coastal areas, based in his present uses.

The administration, use and handling of the coastal areas both have the development through a process of management integrated with the objective to enhance planning and the coordination between institutions, among them the CFIA.

In that process of integrated management, topography and geodesy in Costa Rica must be direct to a technical base that guarantees the administration of the territory. This technical base is very important in the professional formation of the surveyors, but also in the application of effective legislation for planning.

In fact, in the directions stated by the Law of the Terrestrial Marine Zone, the specific functions of the institutional authorities are delegated in protection, administration and handling of these coastal areas. However, if there are no key institutions involved, the resources necessary to keep and to equip the country with a suitable cartography, will not be enough to achieve a well develop system. Therefore it is imperative to point this situation in order to alert and promote the implementation of technical, legal and economics measures that will give as a result a better security to the institutions.

The work that has to been done at regional level has result in a change in how coastal areas should be manage, mainly by putting in practice the matters discussed in this Sixth Congress.
